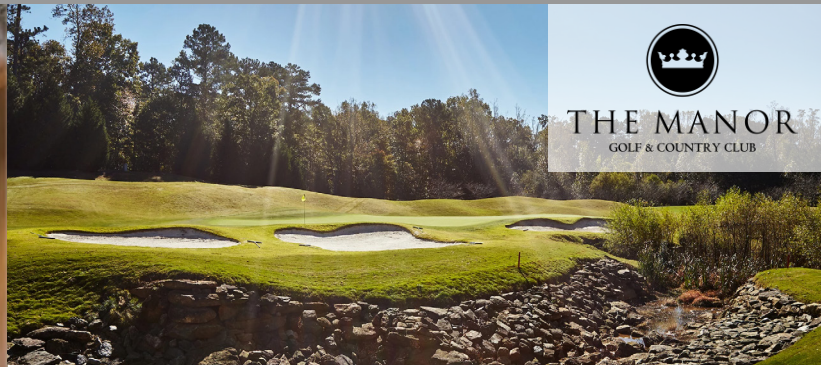

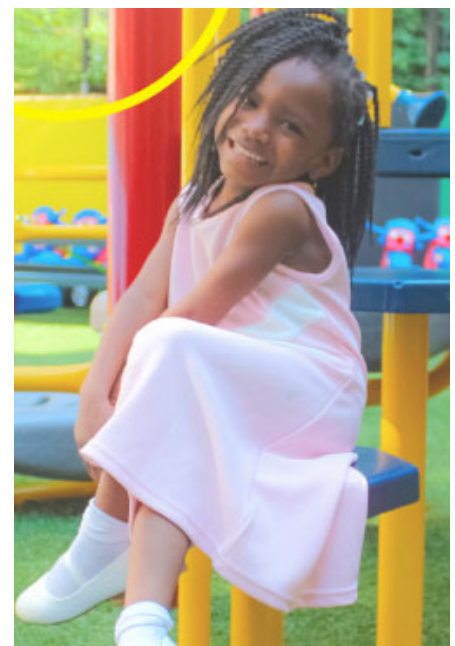

LEGAL CORNER

Implementation of the OSHA COVID-19 Vaccination and Testing Emergency Temporary Standard is On Hold Once Again

In the latest flip-flop of court decisions regarding the OSHA COVID-19 Vaccination and Testing Emergency Temporary Standard (the “OSHA ETS”), the United States Supreme Court decided on the afternoon of January 13, 2022, that a stay of the OSHA ETS requirements is proper.

Initially, the United States Court of Appeals for the Fifth Circuit entered a stay of the OSHA ETS, putting a halt to its implementation. Subsequently, on December 17, 2021, the U.S. Court of Appeals for the Sixth Circuit dissolved the Fifth Circuit’s stay of the OSHA ETS, practically removing any court barrier to implementation and allowing the OSHA vaccination or testing mandate applicable to companies with 100 or more employees to move forward.

However, immediately following the Sixth Circuit’s decision, OSHA ETS challengers (including states, businesses, and non-profit organizations) appealed to the United States Supreme Court, requesting the Court reinstitute the stay of the OSHA ETS and implementation of its requirements.

On January 13, 2022, the Supreme Court, after hearing expedited oral arguments on the issue, entered a stay of the OSHA ETS, once again pausing the implementation of the vaccinate or test mandate. The Supreme Court found that the purpose of OSHA is to set workplace and occupational safety and health standards. The Supreme Court concluded that the ETS addresses public health broadly, which falls outside of OSHA’s expertise.

For now, covered employers will not be required to comply with the OSHA ETS requirements.

However, the Supreme Court’s decision is not necessarily the end of this tumultuous legal battle. Now, the ultimate issue of whether the U.S. Secretary of Labor lacked authority to impose the OSHA ETS will go back to the Sixth Circuit for consideration. Specific information regarding the OSHA ETS requirements can be found here.

At this time, implementation of President Biden’s Executive Order 14042 mandating that all covered federal contractors and subcontractors working on covered federal contracts provide proof of vaccination has also been stayed nationwide. An appeal of the nationwide stay of this mandate is pending at the United States Court of Appeals for the Eleventh Circuit. Specific information regarding the status of the federal contractor vaccine mandate requirements can be found here.

Smith Currie attorneys are monitoring developments in the federal contractor and subcontractor vaccine mandate, as well as the OSHA ETS vaccinate or test mandate, and their impact on the construction industry. We will provide further updates as events warrant.

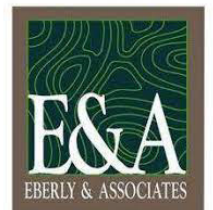
